Narrative

On 4/27/2012 around 2000 hours I was called out to the Re-creation retreat at 235 south main. When I arrived on scene Randy Soderquist was out side waiting for me. When I arrived Randy told me that Ashley Ciciliano was a girl that was in the program, and she wants to break Cassia out and take her away form this place. I asked Randy how do you know that. Randy told me that they intercepted some messages on the computer back and fourth. I asked if they have any of the messages that I can get. Randy told me its in their main frame. I asked Randy when this was going to happen, Randy said Sunday night after 2300 hours. I told him that I will get some more officers and make a plan with them.

On 4/28/2012 around 1000 hours Randy called me and asked if I could come down to the Re-Creation Retreat. When I arrived Randy told me that it was going to happen tonight (Saturday). I called the guys and said to be ready tonight. The Staff came

and said where going to talk to Cassia. I asked them if I could sit in and ask a few questions. The staff didn't have any problem with that. They brought Cassia into the front office and told her to have a seat. Rob asked if Cassia knew

why she was here with all of us. Cassia said she didn't have any idea. Rob said

you know why you are here, tell us about your plan with Ashley. Cassia said she didn't know what we are talking about. Rob said that we know that you two have been talking we found it on the computer. Cassia said that Ashley wants to get her out and it will be in a matter of time when it happens. Cassia said that all she wants to do is get high off meth and die young. I noticed that both of her arms where scabbed over.

Around 2000 hours we set up in the parking lot waiting for anyone to come on the property. 0100 hours nobody showed up we went home and said that we will come back on the 29 of April and watch again. On the 29 of April around 2000 hours we waited for Ashley to show up and we didn't see anyone. I told the staff to keep the doors locked on the out side.
