Hi! The government doesn't sponsor the accreditation bodies it recognizes, it simply recognizes accreditation bodies that meet basic standards for that industry. It's part of

regulation and if you believe in climate change and want the government to regulate businesses that impact that, then you can't hypocritically ignore that you too must be regulated to the extent society requires for your business which would at minimum include being licensed so any complaints are public record and help with overall regulation. So, non-profit or faith-based (anything not approved by the NIH, FDA, etc as food, drugs, or legitimate health services) must operate as non-profit and disclose they are faith-based if aligned with existing regulations otherwise it is fraud as a matter of law and existing regulations pertaining to business operations in the USA.

The National Certification Board of Therapeutic Massage and Bodywork is not a legitimate accreditation body. A legitimate accreditation body for that would be Commission on Massage Therapy Accreditation and that's the only one nationally recognized. Through what licensing board so I can verify that, that would help get you removed from the watch-list. The Australian Breathwork Association may or may not be a scam, but, the International Breathwork Foundation is a cult/scam. So, while I appreciate you may too be a victim of fraud and just never realized it because it is such a big lie and fraud that you being unduly influenced by it bought into it and don't realize even now that you too are a victim.

But, I would suggest getting certified through a massage therapy school accredited by the Commission on Massage Therapy Accreditation and then get back with me or prove you are a licensed massage therapist or that your business is at least licensed as an LLC and provide any and all disclosures, contracts, waivers, indemnity clauses too, that your

clients must sign to receive any services for cash.

I do hope you can provide the information requested and would still like you to clarify whether you consider your e-mails to me feedback or not. So, I've exercised due diligence and am open to additional information if the research I've done independently is incomplete and requires correction. Otherwise, it would appear that Sacred Breath Academy is credible in regards to likening themselves to you which isn't helpful to getting you removed from the watch-list.

Dear Giten,

Thank you for responding. It will help me if you can provide your accreditation and licensing information so I can verify that. If it checks out, I'll be happy to remove you from the watch-list. I am in agreement that Sacred Breath Academy has no credibility and therefore their claims to be similar to your institute are questionable. At this time, your program is listed in yellow because more information is needed before determining whether or not there is fraud given Sacred Breath Academy is clearly a fraud (unlicensed, unaccredited, unqualified) and they've stated you are the same. So, if you can provide how you are different than Sacred Breath Academy, including any professional licensing for healthcare or mental health services, accreditation for academic services including certification authority and

recognition, that will be a big help. And, if you can clarify that you are not involved in human trafficking, associated with Jeffrey Epstein, or any sex trafficking, that would also differentiate you from Sacred Breath Academy if you've seen <http://www.heal-online.org/breathless.htm>. Sacred Breath Academy belongs on the watch-list and reports you are the same as they are and I find they lack credibility, but, need more confirmation that you are different before making any changes. I also need to know whether or not you'd like your e-mail(s) to me to be considered Feedback for posting at <http://www.churchofphilosophicalexploration.ch/feedback.htm>. Transparency and avoiding hypocrisy while being as honest as humanly possible is the cornerstone of COPE Ministries.

Again, I appreciate your getting back with me and hope I can remove you from the list with additional details and/or that you will permit this exchange to be posted in Feedback if that is your intent.

Dear Biodynamic Breath Representative,

Greetings. You are on my mission's watch-list for alleged fraud and abuse. The means by which you were added was different than most. One of your competitors who found themselves on the watch-list after issues with their services were made known to us landing them on the watch-list, demanded we add you to the watch-list as well.

Typically and generally, honestly never before has someone on the watch-list demanded we add their competitors to the watch-list or suggest additional similar frauds, cults, or abusive entities be added that they liken to themselves. But, regardless, you are on it and we have recognized some red flags including any association with Sacred Breath Academy which asked your program be added to our watch-list likening yours to theirs. But, we are offering a means of getting removed from the watch-list to all who are on it at this time regardless of placing party. Honestly, I don't find Sacred Breath Academy remotely credible, but, the fact that they both claim to be like you in their practices (with the horror show that is the information on it which includes being banned in Colorado) and demanded I be fair and include anyone they liken to themselves on the watch-list too. So,

even some clarification from you on how you are different than Sacred Breath Academy, might help get you off the list. We've removed AMITA, Josselyn Center, and NCS Youth Home after successful dialogue with those service providers. This is sincere and I'm acting in good faith.

As a result of complaints and/or requests to investigate your program submitted to our ministry and mission regarding alleged abuses at your location, your program is on our watch-list of suspected and/or confirmed fraud and abuse.

And, HEAL is our mission to expose false prophets (regardless of storefront or cultural influence) in the segregated congregate care, academic, and healthcare fields. Your program is on our watch-list at <http://www.heal-online.org/thelist.htm>. And, attached are two and 1/2 offers you can accept at any time to be removed from our watch-list or provide feedback. Please see attachment for details. The suggested complaint board should be read as a feedback board for both complimentary and critical feedback where all is allowed without censorship and complaint resolutions are shared by your program.

If you choose to provide feedback and forego the first offer (with option), please understand we will reply to your feedback and any and all dialogue will be posted to our Feedback page at <http://www.churchofphilosophicalexplorati>

[/feedback.htm](#). If you do not wish for our dialogue to be posted to the Feedback page do not identify it as Feedback and expressly state it is not Feedback. In such a case, we may not read it and the purpose is to highlight and show our humility and willingness to admit imperfection because only God is perfect. If you choose not to participate or feel it would be hypocritical to do so after reading and declining the attached offer, I understand.

This offer is being made because others in your industry asked, requested, and/or demanded we create a "white list" for programs that meet our standards. Our minimum standard is honesty in marketing to avoid violating the Nuremberg Code regarding informed consent.
