

DISARMING NARCISSISTS AND ADDRESSING CONFUSION

This particular "Fact Sheet" includes hypothetical dialogue as an example of what it is like to have a conversation with a malignant narcissist so you can recognize the Cains/Lucifers in your life and protect yourself by reclaiming your own autonomy and authority as an individual. The issue is that sometimes malignant narcissists falsely assume authority over others and through manipulation and abuse manage to convince their "recruits" or "subjects" that they are an actual authority when they are not as a matter of law in most cases involving non-adjudicated adults. But, malignant narcissists sometimes have children and the law recognizes the parents as the authority unless and until someone turns the parents in for crimes they've committed. And, where children take learning what they live too far under malignant narcissist authority things like Stephen King's "Children of the Corn" are inspired. So, a real life example might be the Menendez Brothers. And, facts help. But, the following dialogue and this fact sheet can be handed to any malignant narcissist in your life that you want to enlighten and just tell them having a conversation with them is like having a conversation with the narcissist in the dialogue here. If a person of faith you may feel it is up to you to try to "save" the narcissist because their criminality or viciousness makes them a danger to themselves and others. But, I personally feel that in terms of the separation of church and state, the Cains/Lucifers belong to the state or Caesar and I'm happy to point them in the right direction or notify the authorities should human trafficking or harm to children be involved. I see churches as manifestations of good faith and good works that don't need interference from those acting in bad faith doing malicious acts. I appreciate that the government agrees and will remove those acting in bad faith doing criminal malicious acts upon effective notification which includes at times enough evidence presented by victims and witnesses to prove guilt beyond a reasonable doubt.

YOU AND THE NARCISSIST IN CONVERSATION:

Narcissist: You must come try my salad. It's a new recipe and truly divine.

You: What's in it?

Narcissist: I can't reveal that. It's a secret.

You: I have allergies and must know.

Narcissist: Assume the risk, I'm sure you will be fine.

You: Let me have a small bowl. What are these? They look like Holly berries. Those are poisonous.

Narcissist: They are the cutest little tomatoes I found growing outside. I didn't even know they grew this time of year. But, they are so pretty so I used them as a garnish.

You: You need to stop using the Holly berries as they will cause serious stomach upset and in animals, children, and/or the elderly may actually cause death when ingested to the extent you've used them.

Narcissist: You don't know anything. Those are not Holly berries. Those are little tomatoes. You are stupid. You don't know. Don't eat it! You are not good enough to eat it! You don't deserve to eat it! Only people who recognize the divinity of my salad can eat my salad!

You: Please don't ask me to eat anything you make or even interact with you again.

Narcissist: Why would I? All you do is criticize! You only complain! You don't even recognize the bounty before you! That salad was hard to make! It took me all day! I had to pick the tomatoes myself! You are a total narcissist! You think you know everything! I don't want to talk to you and I'm getting a restraining order to make it official!

You: I'm taking the salad to the police station and telling them I think you just tried to poison me. Hopefully it will at least establish a complaint record in the event you actually kill someone by way of your delusions of grandeur and/or confusion regarding the difference between Holly berries and tomatoes which just proves you have no palate and know nothing about produce.

The bottom line is vicious idiots pretend to be authorities because they are intimidated by the educated and informed so they manufacture illusions around themselves to avoid feeling inferior rather than applying themselves to actually offer something of value when seeking to trade in some way.
