

IN KIND DONATION AND PERPETUAL FUNDING GOALS INFORMATION:

With in-kind donations as those referenced on the fellowship page and elsewhere, it is customary for the donors to set the value. So, while the church has modestly estimated the annual value of the inspirational art provided at a minimum total of \$45,625 (which is 10% of what the arguable value of said donations is at this time depending on how calculated, so an equivalent of a typical tithe and shows modesty on part of the contributing inspirational artists), the actual value is determined by the artists and/or volunteers, depending on subject reference, themselves at tax time and if \$5,000 or greater annually objectively reviewed by an IRS tax appraiser. And, the church currently estimates mission volunteer in-kind donations to be a minimum total of \$31,937.50 which is based on equitable recognition for all in-kind donations so as to treat everyone equally in the spirit of Founding Father Priest John Ball. Our volunteers provide expert and specialized peer support assisting victims with navigating the system for remedies available at law. Parent Support volunteers include medical professionals and one holds a juris doctorate. And, the inspirational artists are quite often more widely celebrated than not so both objectively and subjectively worthy of the arguable estimated valuation. With cash (including checks, online, and cash) donations, all those received in 2020 and perpetually recognized going forward on the page at <https://www.cope.church/fellowship.htm> . If you'd like to see the church and mission maintained, upgraded, and/or fully physically manifested, please give today. To maintain just the websites and phone systems for the church and mission services which include responding to and providing virtual sanctuary for victims and survivors of institutionalized abuse and human trafficking to assist with reporting and support, it is \$1800 (fluctuates but last estimate based on monthly expenses was \$1788 for the year for those services alone). Our annual minimum fundraising goal is set at \$12,750 and subject to change depending on poverty guidelines such as those shown here: <https://aspe.hhs.gov/poverty-guidelines> The maximum fundraising goal is set at \$18,205.85 (see <https://www.cope.church/challenge.htm> for info) So, please know all donations are welcome whether in-kind or of a monetary nature. VALUATION OF VOLUNTEER AND/OR GUEST SPEAKER/SERMONIZER/AUTHOR CONTRIBUTIONS MAY BE BASED UPON:

Rev. Angela Smith is extremely qualified and you can see her credentials at <https://www.cope.church/credentials.pdf> and more at <https://www.cope.church/goodshepherd.htm> . Objectively, based on qualifications and for profit corporate valuations based on said qualifications, Rev. Angela Smith is worth \$65K + Benefits (health insurance) annually. However, in the spirit of humbleness and modesty to lead by example has taken a vow of poverty in solidarity with all "have nots" which explains the minimum and maximum fundraising goals described above and in literature about the mission and church.

As far as the valuation for in-kind contributions of artists, volunteers, guest speakers, guest sermonizers, and guest authors, the argument supporting tax-deductible receipts for said contributions to the church and mission are described below:

Contributing Artists: Arguable value for providing perpetual art for the church and mission is based on union scale for actors. So, $\$125/\text{day} \times 365 = \$45,625$ and as a reverse tithe in consideration of the artists as also churches that would customarily be 10% so the church values it at $\$4,562.50$ annually per contributing artist though the artists themselves may value their contributions differently per the standard with in-kind donations.

NEW MEDIA SAG AGREEMENT - LESS THAN \$250K

For New Media projects less than \$250,000 (but greater than \$50k), expect to pay performers a minimum rate of \$125 per day. Like other low budget agreements, there's only a SAG day player rate.

- **Budget Range:** \$50k - \$250k
- **SAG Day Rate:** \$ 125 / day
- **SAG Weekly Scale:** None


NEW MEDIA SAG AGREEMENT - \$250K - \$700K

New Media productions with budgets between \$250,000 and \$700,000 should expect to pay major performers either \$335 per day, or \$1,116 per week.

- **Budget Range:** \$250k - \$700k
- **SAG Day Rate:** \$ 335 / Day
- **SAG Weekly Scale:** \$1,166 / Week

Contributing Survivor and Parent (Peer) Support Specialists: Retired Police Captain Charles Kennedy has special knowledge and skills that assist with helping victims of torts and crimes. Helen Taylor with Parent Support is a nurse, educator, and also holds a juris doctorate. So, it is clear their talents are special and would otherwise need to be paid for if not donated. The same is true of all mission volunteers who are also survivors/victims of torts and crimes that provide assistance to other survivors. So, the valuation on all such support specialists is based on this (though to treat everyone fairly and not show favoritism it could also be valued at the contributing artist rate which is the basis originally used for the valuation of volunteer support contributions) and depending on variables such as actual time donated/contributed in volunteering using a full-time value of the services provided as that shown below though 10% of that would be aligned with

the spirit of church policy traditionally (So, between \$3800-\$4,705.20 and the artist valuation is in that range):



Contributing Guest Speakers/Guest Sermonizers/Authors: Most of our guest speakers, sermonizers, and contributing authors are survivors and victims of torts and crimes. The going rate to pay for such contributions per event or publication is based on the information provided in the screenshot below which suggests each contribution of that kind has a market value of \$2,499-\$7500 in the for profit sector.

Therefore, such in-kind contributions are eligible for and/or receive a tax receipt from the church which can be applied to annual income tax for a refund or tax credit.

As a Wycliffite Church, there is no way that volunteers and contributors, even if only giving in-kind, shouldn't be considered to have value that is meaningful and rewarded by the government recognizing the good works as contributing to the good of society in a manner that if shown to have objective for profit fair market value may be deducted or counted as an in-kind contribution. And, that's true. So, all the volunteers who do not make the HEAL Mission and COPE their full-time gig, can deduct the value of their in-kind services. It is, however, Rev. Angela Smith's full-time gig and donations are appreciated and help provide the mediums by which all of our mission volunteers and church contributors provide service to over 28,000 at this time (October 12th, 2020).
