So, given that the only similar businesses or trademarks have been Sacred Breathwork Journeys LLC, not run by a mental health or medical professional and Sacred Breathwork out of Michigan (Sacred Breathwork TM dead according to TESS), it is a total scam/cult.

Shall I continue? No. Because, I've looked into every state where they've been or have claimed to operate in the last year. So, if not licensed in any of those states, practicing without a license because you need at least temporary licensure to offer medical or mental health services in a state that isn't your home state. They are called interstate transfers and come with a temporary status.

Also, not an accredited academic service so certification is worthless.

I even checked Delaware where most LLCs and frauds get licensed regardless of where they choose to open up shop. But, not licensed there either:
