

CONVERSION PROGRAM PROGRESS REPORT: Sacred Breath Academy AKA  
Sacred Breath Institute in CA (Global/Mobile)

The HEAL Mission of COPE has received 6 separate complaints from individuals and families (one of whom is me, Rev. Angela Smith) alleging deceptive marketing, fraud, deceit, academic fraud, food deprivation, extortion, communications censored/monitored/restricted, emotional abuse, spiritual abuse, psychological abuse, coercion, sexual coercion/abuse, labor exploitation, fat-shaming, ageism, kidnapping by fraud, unqualified staff (lack any professional credentials whatsoever), unlicensed, not accredited to issue certifications or diplomas of any sort, and undue influence at Sacred Breath Academy. Some of these complaints are referenced online and others remain confidential and on file with the church.

As a result of this particular program expressly choosing not to participate in the COPE Conversion Program opportunities to address complaints, questions, and/or resolve differences where possible, but, rather protesting COPE and the HEAL Mission as well as their own placement in the Conversion Program/on the watch-list there was no round table invitation sent out. While I, Rev. Angela Smith, would be happy to host and moderate a discussion between Sacred Breath Academy representatives and all the victims who've reported it (including myself), Sacred Breath Academy would prefer not to participate. Therefore, the victims find sanctuary here and a platform to help warn others in an effort of consumer advocacy where arguably too intimidated to report it to the proper authorities given the level of harassment that resulted simply from asking about licensing, accreditation, and qualifications of staff.
